Patent Troll Progress

East Texas has become a hotbed for a booming patent industry, where innovators can protect their intellectual property because of the speed and access of local courts. Unfortunately, patent trolls have created a cottage industry to prey on these innovators and file abusive lawsuits. We'll be watching the outcome of the 2014 legislative hearings on patent trolling; this interim legislative study has been ordered by Lt. Governor David Dewhurst for a possible legislative fix in 2015.

Lawsuit Lender Lookout

Another concern in Texas is the growth of the wholly unregulated lawsuit lending industry—those who prey on people when they are at their most vulnerable by offering loans to back litigation with extremely high and unregulated interest rates. We urge those who have been abused by this industry to speak up and fight back against lawsuit lenders this year. We will continue to speak out about this abusive industry.

Continue to Address Problems in the Legal System

Our lawmakers and judges play an important role in ensuring our courts are fair for everyone. While our state has a great record of passing lawsuit reforms, we need to continue the progress in trouble shooting the process when new problems arise.

Vote Smart

As we look toward the 2014 elections, it's important that voters know the candidates running for in legislative and judicial offices. We want to make sure voters ask the important questions to know who they are voting for, where their candidates stand on the issues and who is supporting their candidates for office.
